REQUIREMENTS FOR ETHICAL REVIEW AND APPROVAL OF RESEARCH PROTOCOLS

- 1. Applicants must Fill in the GLUSERC application form and submit 3 hard copies and softcopy also to be submitted the email: ethicalreview@gluk.ac.ke
- 2. Applicants must Submit Research protocol: THREE (3) bound hard copies to the Secretary in and a soft copy to be sent to the provided email address: ethicalreview@gluk.ac.ke
- 3. Applicants must Submit a Plagiarism report for their protocol a soft copy to be sent to the provided email address: ethicalreview@gluk.ac.ke
- 4. The Applicant must Provide the Payment Receipt in hard Copy and Softcopy
- 5. Applications MUST reach the Secretary, two weeks before the date of sitting.
- 6. The application must be duly signed as indicated with the original in inked signature.
- 7. Expedited review meetings can be called within convenient interim dates that favor a minimum quorum. All applications for expedited review must have undergone scientific review and been granted approval.
- 8. Review results will be communicated to the PIs and Supervisor(s) within (5) working days of the meeting at which the decision was made and further requirements clearly stated.
- 9. Regulations require continuing review must be at least every 12 months. The review period will reflect an interval appropriate to the degree of risk. Continuing review has a separate application form that can be obtained on request.
